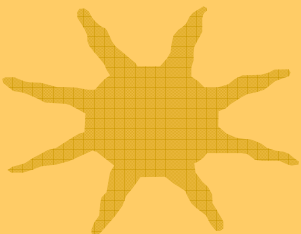
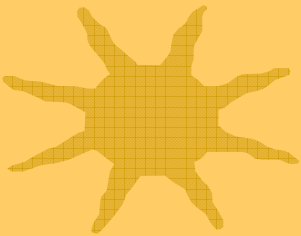
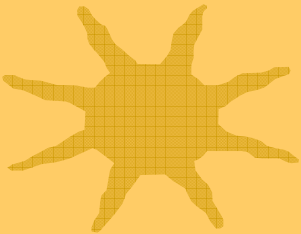
1 Introduction
